Royalty Contestant Rules

Age Groups- The age groups are based upon the age of the contestant on the day of the pageant.

Groups are as follows:

Ages 4 to 6: Lil Miss Chili Fest; All natural nothing fake (makeup, nails, tanning) No cupcake dresses.

Ages 7 to 9: Junior Miss Chili Fest; All natural nothing fake (makeup, nails, tanning) No cupcake dresses.

Ages 10 to 12: Miss Chili Fest; Age Appropriate make up. No cupcake dresses

Ages 13 to 15: Miss Teen Chili Pepper- Age Appropriate- pageant style dresses permitted or formal wear

Ages 16 to 21: Miss Chili Pepper- Age Appropriate- pageant style dresses permitted or formal wear.

General Contest Rules

Each age category will have winner and at least one runner up in category. All judge's rulings are final. In addition, pageant will have one winner of Miss Congeniality and one winner of Miss Photogenic.

All participants must sign photo release form for the Wetzel County Chamber of Commerce.

All winners will be required to participate in 2013 Chili Fest on Saturday, October 26 from Noon until 4pm. Participants will also be required to participate in Chamber of Commerce Annual Christmas Parade on Saturday, December 7th, 2013

There are no residency requirements, candidates may be from all local areas.

Contestants may hold other titles from other pageants.

Registration fee of 10.00 is required at time of entry. All entries must be received by Friday, October 18, 2013 by 4:00 pm.
